Types of Memberships *

Builder Members: Builder members are directly involved in building or remodeling homes, apartments, schools, industrial, commercial, or other structures related to a community, or in land development. They include small-volume builders, production builders, light commercial Builders, land developers and remodelers. A builder joins NAHB through his Local home builders association.

Associate Members: Associate members are members who provide products or services to the home building industry. They include trade contractors and professional service firms such as insurance or mortgage companies. An associate joins NAHB through his Local home builders association.

Affiliate Members: Affiliate members are *employees* of Builder and Associate members. The Affiliate membership allows employees to enjoy NAHB benefits at a reduced dues investment. Not all HBA's offer the affiliate membership, nor is it a requirement to do so.
